5. Website

- Our current website was almost 6 years old
- Drupal 6 is obsolete since September 2015
- The site was shut down earlier than expected for security reasons
- New development since October 2015 by Makemeweb
- o The new site is still under construction but will be online soon and available for simple functions
- Odile does a little presentation of the new site.
- In the future, we have to budget the fact that, due to technologic evolution, we have to pay for a new site every 5 years about 25k€

We need SPONSORING

- a. Existing ones continue (Simple (300 € per year and Main 200 € per year)
- b. Proposal of highier tier sponsorhip (2500 €): "Lunch Symposium + Main sponsor on the website ie 30 min slot during lunch at the symposium (2 or 4 per symposium day)
- O Questions from the audience: Why do we have to increase the prices (example: extra fee and new sponship) if the sponsors already bring about 5k€ minimum per year? The president answers that with such amount, we just maintain ourselves but we cannot develop anything or invest in new materials.

- 7. Scientific Activity and Collaboration F. Vanhoutte and M. Tomsej
 - The BHPA wants to support more collaboration between physicists an knowledge sharing. For example, we want to present the project of Milan Tomsej:
 - o Milan needs help and center support to study a new detector. See SLIDES
 - Each participating center must provide simple data for its linac to model it in the software then realizes a treatment planning and measurement with the detector (Compass Software and Dolphin)
 - ii. The first round will begin in may
 - iii. Already 13 centers willing to participate
 - iv. Please continue to show your interest if willing to join
 - Such project already exists outside BHPA but BHPA could and should be used for such collaboration.
